Welcome to Indiana Beach!

Welcome to Indiana Beach Amusement & Water Park Resort! Nestled on the shores of Lake Shafer in Monticello, Indiana, at Indiana Beach we strive to make your time with us enjoyable and hope that this Safety & Accessibility Guide will assist you during your visit. Please ask a uniformed team member for assistance or visit Guest Relations located inside the park if you have additional questions! Again, welcome and we hope you enjoy your visit!

A Note Regarding Safety

We are committed to the safety of all our Guests and team members. Safety is a partnership between the park and you, our Guests. Please observe all warnings outlined in this guide and other rules and safety information provided to you by our team members. The information in this document was updated before the start of the season. Information in this guide is subject to change.

If you suspect your health could be at risk for any reason, or you could aggravate a pre-existing condition of any kind, **DO NOT RIDE**. Specific warnings and restrictions are listed at each ride and within this guide.

All Guests must be able to demonstrate a willingness and ability to comply with verbal and written rider requirements. Guest unwilling or unable to follow instructions or comply with directions given will not be allowed to ride.

Indiana Beach reserves the right to make the final determination on a Guest's ability to ride and may deny a Guest access if Management deems it unsafe for the individual. Any Guest who does not fit properly in the ride restraint or vehicle will not be permitted to ride.

General Information

Parking

Parking is available for Guests with disabilities in the main parking lot located at the north end of the park on a first come, first serve basis. A valid disabled persons parking placard or license plate must be displayed at all times while parked in designated accessible parking areas.

Family and ADA Restrooms

Family restrooms with ADA accessibility are available near the Tilt-a-Whirl ride just inside the waterpark and at the south end of the park under the Skyride platform.

First Aid

First aid is located under the Cornball Express and near Dr. Frankenstein's Haunted Castle. If you require medical assistance, please ask for help from any of our uniformed team members and they will contact first aid for you.

Pregnancy

Pregnant Guests, or Guests who believe they may be pregnant, should follow all rules and guidelines listed for each ride. Guests who are pregnant shall not ride an attraction that specifically lists pregnancy as a rider restriction.

Segway, Hoverboards, and Wheelchairs

Segway, Hoverboards, or other two-wheeled, self-balancing electric vehicles are not permitted within Indiana Beach property. Limited numbers of Wheelchairs and Electric Convenience Vehicles (EVC) are available for rent on first come, first served basis inside Guest Relations. Golf carts are not permitted in the boardwalk or midway areas at any time.

Guests are permitted to use their own EVC or wheelchairs within the park.

Outside Food

Indiana Beach does not allow outside food inside our park. Guests with special dietary needs will be allowed to bring limited portions into the park to accommodate their needs for the day. Please see a team member at the gate for assistance.

Cameras

Cameras or video equipment, including cell phones, are not permitted on most attractions, the exception being the Shafer Queen. All other attractions prohibit the use of these items while the ride is in motion. Guests are instructed to place all loose articles in a park locker or leave them with a non-rider. Please remember, Guests must have written permission to use photographs and/or recordings of any aspect of the park for commercial broadcasting, advertising, marketing, or publishing in any medium. The use of a waterproof sport camera while in any water attractions is **NOT** permitted. These are considered attractions and loose articles are not allowed.

Oxygen Tanks and Devices

Oxygen tanks and machines are not permitted on all rides. For the safety of all Guests, oxygen tanks and small personal oxygen machines are permitted on the following rides only:

- Shafer Queen
- Wabash Cannon Ball Express "Train"
- Giant Gondola Wheel

Oxygen machines that can be secured to you in a similar manner as a purse or bag will also be permitted on the Antique Autos.

Oxygen tanks and devices must be small enough to be secured safely between the rider's feet or held in their lap and secured to their person while riding. Devices that do not meet these requirements will not be permitted on any ride or attraction.

Service Animals

Trained service animals are welcome at our park. Service animals are defined as any dog or miniature horse that is individually trained to do work or perform tasks for the benefit of an individual with a disability, including a physical, sensory, psychiatric, intellectual, or other mental disability. The work or tasks performed by a service animal must be directly related to the individual's disability (ADA Title II and III). Dogs whose sole function is to provide comfort or emotional support do not qualify as service animals. Miniature horses that have been individually trained to do or perform tasks for people with disabilities will qualify as service animals.

Service animals must be housebroken and remain on a leash or harness or under control of the individual they assist at all times. Guests whose service animal demonstrates aggressive or uncharacteristic behavior towards a Guest or team member will be directed to remove the animal from the park.

We welcome service animals in most areas of our park. Many of our rides are not equipped to accommodate service animals, and the animal will not be allowed to ride most attractions. A member of the party must be available to stay with the animal while the Guest rides.

The park has a service animal relief area located in the area behind the Big Flush water slide at the north end of the park and on the island near the train station at the south end of the park. Owners are responsible for clean-up and disposal of their animal's waste.

Exit Boarding Pass

Exit Boarding Passes are available to provide access to park attractions for Guests with limited mobility or other qualifying circumstances and not to bypass another Guest waiting in the standard queue. Guests who qualify for this access should visit Guest Relations inside the park to obtain one.

Exit Boarding Passes will allow access for the qualifying Guest and up to one other riding companion. If the Guest's party is larger than two people, the rest of the party will need to enter the attraction through the standard queue. The Guest issued the exit pass must ride for the Guest companion to use the alternative entry and bypass the standard queue.

Guests who obtain an Exit Boarding Pass must still meet all safety and rider requirements to participate in any ride or attraction within the park. Entry, exit, and transfer to the ride must be accomplished independently by the Guest or with assistance from a member of the Guest's party. Indiana Beach team members are not trained to lift, carry, or assist with transferring of a Guest and are not permitted to assist a Guest on or off a ride. Not all rides have alternative access; please refer to this guide, Guest Relations, or a team member if you have questions.

Ride Evacuations

In some instances, there may be a need to evacuate a ride from a location other than the standard load and unload position. Guests may need to negotiate stairs from the highest points of the ride and down steeply inclined walkways. Guests requiring assistance during a ride evacuation may be escorted last to expedite the evacuation process. Persons with limited mobility should be accompanied by a companion capable of helping to evacuate them during a ride shut down if needed. Please ask about specific procedures prior to boarding a ride.

Ride Information

Theme and waterpark attractions will expose riders to forces, speeds, and other intense elements that may cause distress or injury to individuals with pre-existing conditions. As a rider you should be in good health and heed all warning signs and attendant instructions.

To experience all rides, Guests must be able to maintain the proper riding position throughout the ride, including maintaining control of upper torso, head, and neck. Riders must meet the ride requirements and appropriately utilize the restraint systems, including lap bars, shoulder harnesses, and seat belts as indicated.

Guests with casts, braces, and prosthetics may be restricted from riding certain rides where these items may present a hazard to the Guest or other participants. Some rides may require a Guest to remove a prosthetic, brace, or assistive device to ride.

Definitions

Rider requirements and rules are listed at every ride or attraction entrance. Indiana Beach uses the following terms:

A responsible adult may be required to help the Guest while loading, unloading, and while a ride is in motion. This person must also be able to assist the party they are responsible for in the event of a ride evacuation. |
| Functioning Arm | A full arm with the ability to be flexed at the elbow and a minimum of three full fingers with the ability to grip or brace. |
| Arm Remnant | A partial arm up to the elbow joint. |
| Functioning Leg | A full leg with a foot and the ability to control the extremity. |
| Leg Remnant | A partial leg up to the knee joint or beyond. |

Rider Responsibility

As a Guest at an amusement park, you have a duty to exercise good judgement and act in a responsible manner while participating on a ride or attraction and to obey all verbal and written warnings and instructions. The State of Indiana Administrative Code Title 685 Section 1-2-4 requires the following of amusement park patrons:

- Patrons have a duty to not participate in or on any amusement ride, device, or attraction when under the influence of drugs or alcohol.
- Patrons have a duty to properly use all ride or device safety equipment provided.
